Spring 2024 Tapping Luncheon Speaker

Marní B. Lennon, J.D.



Marni Lennon is the Assistant Dean for Public Interest and Pro Bono and a Lecturer of Law. She is the founder and director of the HOPE Public Interest Resource Center, has worked and taught at the University of Miami School of Law for 28 years, serving for the last seventeen years as the Assistant Dean for Public Interest and Pro Bono. Prior to this role, she served as Interim Dean of Students, Asst. Dean of Students, Director of Disability Services and Deans' Liaison to Students.

Among other public interest initiatives, she established the HOPE Fellows Program, which provides students with opportunities to work locally, nationally, and internationally in public interest organizations. Lennon also directs the Miami Scholars Program for students who demonstrate an exceptional commitment to public interest advocacy and who possess outstanding academic credentials, serves as co-advisor to the Public Interest Leadership Board, and works closely with student organizations engaged in community outreach and advocacy. She is also a guest contributor to The Pulitzer Center.

Dean Lennon teaches Alternative Dispute Resolution, ADR Design Systems, Mediation and Social Justice Lawyering, and is a Florida Supreme Court Certified Family Mediator. She has served in numerous leadership roles for the Student Services Section and the Pro Bono Section of the AALS. She is also the author, with Melvin Rubin, of *Mediation*, in 3 Florida Family Law 55-1 (Brenda M. Abrams ed. 2012) and *The Vulnerable Client: Standing at the Crossroad of Compassion and Competence*, with Jan Jacobowitz (MIE Legal Aid Journal, Summer 2018). She recently presented research on Halting the School to Prison Pipeline at the American Bar Association's Mid-Year Convening.

Dean Lennon currently serves on the Board of Southern Legal Counsel and the Board of CETLAW. She is also proud to serve as the Co-chair of the Deans' Circle for the Squire Patton Boggs Foundation. She is a member of the ABA's Coalition on Racial and Ethnic Justice and a member of the Equal Justice Works National Advisory Council. She speaks on conflict resolution, public interest lawyering, and systemic reform and is dedicated to training next generation of lawyers with a pro bono ethic.

Charles K. George (1929-2023) - Former Miami Hurricane Football player; Sigma Alpha Epsilon fraternity; Founder and Senior Partner, George, Hartz, Lundeen et al; US Air Force JAG Corps; General Counsel, Miami Dolphins; University of Miami Hall of Fame Class of 1995. Iron Arrow since 1952.
